Ladang Jalong Tinggi is the eraliest palm oil estate established by PPPNP in 1975 at Sungai Siput (U) dengan with total area 1,416 hectares. Others ealiers palm oil estate established by PPPNP on 1983 is Ladang Gelong Gajah, Ladang Sungai Selinsing and Ladang Lambor, Ladang Segar established on 1988 and Ladang Pulau Tiga established on 1989.

2 AUDIT METHODOLOGY

This Recertification audit covers the following activities but not limited to the activities described below:

- On-site visits, observations and inspections of estate facilities and field activities.
- Interview operation personnel and field workers for understanding for the work assigned.
- Reviewed revised and updated documentation established and implemented.
- Conduct the Stakeholders' consultation meeting.
- Review and closed out of non-conformance raise during previous surveillance audit.
- Assessment reporting.

The methodology for collection of objective evidence included physical site inspections, observation of tasks and processes, interviews of stakeholders, communities, staff, workers and their families, review of documentation and data. Checklists and questionnaires were used to guide the collection of information. The comments made by external stakeholders are considered in the assessment.

For this audit selected estates were based on the formula $S = Vn \times (risk \text{ factor})$ where S = sample size and n = number of estates which is in accordance with MSPO certification procedure. The sampling methods are as per below with the risk factor is 1. the determination of risk factor are as per Risk Management Procedure (MSPORMP dated 1 October 2019) which is:

 $S = 4.69 \times 1$

S= 5 estate sample

Map 1: Map of Ladang Lambor


Map 2: Map of Ladang Pulau Tiga


Map 3: Map of Ladang Teluk Sena




Map 4: Map of Ladang Ayer Kuning

Map 5: Map of Ladang Pasir Panjang Ulu




Map 6: Map of Ladang Untuk Rakyat Air Kuning




Map 10: Map of Ladang Gelung Gajah




Map 11: Map of Ladang Tualang Tumbuh


Map 12: Map of Ladang Usaha Pahlawan

Map 14: Map of Ladang Masyarakat Kledang Mas




Map 15: Map of Ladang Kledang Saiong






Map 20: Map of Ladang Ulu Rasau


Map 21: Map of Ladang Ayer Kala
